HOUSING IS OBTAINED FOR HOMELESS INDIVIDUALS; FINANCIAL BENEFITS (SUCH AS SOCIAL SECURITY DISABILITY PAYMENTS AND MEDICAID) ARE OBTAINED; MEDICATION COMPLIANCE IS MONITORED; CRISIS PLANS ARE DEVELOPED; LINKAGES TO OTHER SERVICES SUCH AS SUBSTANCE ABUSE RECOVERY ARE MADE; REFERRALS TO PRIMARY PHYSICAL CARE ARE MADE, AND TRANSPORTATION IS OFTEN PROVIDED.
