HOUSING IS OBTAINED FOR HOMELESS INDIVIDUALS; FINANCIAL BENEFITS (SUCH AS SOCIAL SECURITY DISABILITY PAYMENTS AND MEDICAID) ARE OBTAINED; MEDICATION COMPLIANCE IS MONITORED; CRISIS PLANS ARE DEVELOPED; LINKAGES TO OTHER SERVICES SUCH AS SUBSTANCE ABUSE RECOVERY ARE MADE; REFERRALS TO PRIMARY PHYSICAL CARE ARE MADE, AND TRANSPORTATION IS OFTEN PROVIDED. THESE SERVICES ARE FUNDED BY MEDICAID AND LOCAL TAX DOLLARS.

CLIENTS ARE REFERRED FOR PSYCHOTHERAPY, WHICH IS TRADITIONAL TALK THERAPY DELIVERED BY A PROFESSIONAL SOCIAL WORKER. CLIENTS ARE ASSIGNED TO A COMMUNITY SUPPORT SPECIALIST (CSS), WHOSE SERVICES ARE DESCRIBED ABOVE. THE CSS COORDINATES ALL THEIR CARE
