HOUSING IS OBTAINED FOR HOMELESS INDIVIDUALS; FINANCIAL BENEFITS (SUCH AS SOCIAL SECURITY DISABILITY PAYMENTS AND MEDICAID) ARE OBTAINED; MEDICATION COMPLIANCE IS MONITORED; CRISIS PLANS ARE DEVELOPED; LINKAGES TO OTHER SERVICES SUCH AS SUBSTANCE ABUSE RECOVERY ARE MADE; REFERRALS TO PRIMARY PHYSICAL CARE ARE MADE, AND TRANSPORTATION IS OFTEN PROVIDED. OVER 700 CLIENTS RECEIVE THIS SERVICE EVERY YEAR. SERVICES ARE DELIVERED BY A TOTAL OF 24 COMMUNITY SUPPORT SPECIALIST STAFF MEMBERS WITH BACHELORS OR MASTERS DEGREES, USUALLY IN A SOCIAL SERVICE FIELD. THESE SERVICES ARE FUNDED BY MEDICAID AND LOCAL TAX DOLLARS.

THESE SERVICES ARE FUNDED BY MEDICAID, LOCAL TAX DOLLARS, AND GRANT FUNDS.

THE GOAL OF THIS SERVICE IS TO MANAGE PSYCHIATRIC SYMPTOMS WITH THE FEWEST MEDICATIONS POSSIBLE AT THE LOWEST DOSE. MOST CLIENTS RECEIVE THIS SERVICE MONTHLY, THOUGH VERY STABLE CLIENTS MAY SEE THEIR PROVIDER ONCE EVERY THREE MONTHS.
