THE CENTER PROVIDES INTAKE AND DIAGNOSTIC SERVICES THAT ARE CONDUCTED BY PROFESSIONAL SOCIAL WORKERS; EACH CLIENT ADMITTED FOR CENTER SERVICES RECEIVES AN EXTENSIVE INTAKE THAT ASSESSES HIS/HER HISTORY, CURRENT LEVEL OF FUNCTIONING, AND TREATMENT NEEDS. MOST CLIENTS RECEIVE MEDICATION PRESCRIPTION AND MANAGEMENT FROM A LICENSED PSYCHIATRIST OR AN ADVANCE PRACTICE REGISTERED NURSE. CLIENTS ARE REFERRED FOR PSYCHOTHERAPY, WHICH IS TRADITIONAL TALK THERAPY DELIVERED BY A PROFESSIONAL SOCIAL WORKER. CLIENTS ARE ASSIGNED TO A COMMUNITY SUPPORT SPECIALIST (CSS), WHOSE SERVICES ARE DESCRIBED ABOVE. THE CSS COORDINATES ALL THEIR CARE

PATIENT DISCHARGE COORDINATION - THE PATIENT DISCHARGE COORDINATION PROGRAM IS A CONTRACTED SERVICE THROUGH AMERIHEALTH CARITAS DC AND BEACON HEALTH OPTIONS. WHEN THESE MCO MEMBERS ARE ADMITTED TO THE INPATIENT PSYCHIATRIC FACILITY, THE PDC STAFF VISIT THEM AT THE HOSPITAL, PERIODICALLY DURING THEIR HOSPITAL STAY, AND THEN ACCOMPANY THEM HOME AFTER DISCHARGE. OTHER PARTS OF THE PDC PROGRAM INVOLVE BEHAVIORAL HEALTH ENGAGEMENT AND POST EMERGENCY EVALUATION SERVICES. WHEN THESE INDIVIDUALS ARE LOCATED, AN ASSESSMENT IS CONDUCTED BY A LICENSED MENTAL HEALTH PROFESSIONAL, AND APPROPRIATE REFERRALS ARE MADE IN ORDER TO DECREASE THE LIKELIHOOD OF RETURNING TO THE HOSPITAL OR AN EMERGENCY ROOM.
