THE CENTER PROVIDES INTAKE AND DIAGNOSTIC SERVICES TO EACH CLIENT ADMITTED FOR CENTER SERVICES RECEIVES AN EXTENSIVE INTAKE THAT ASSESSES THEIR HISTORY, CURRENT LEVEL OF FUNCTIONING, AND TREATMENT NEEDS. MOST CLIENTS RECEIVE MEDICATION PRESCRIPTIONS AND MANAGEMENT FROM A LICENSED PSYCHIATRIST OR AN ADVANCE PRACTICE REGISTERED NURSE. CLIENTS ARE REFERRED FOR PSYCHOTHERAPY, WHICH IS TRADITIONAL TALK THERAPY DELIVERED BY A PROFESSIONAL COUNSELOR. CLIENTS ARE ASSIGNED TO A COMMUNITY SUPPORT SPECIALIST, WHOSE SERVICES ARE DESCRIBED ABOVE. THE CSS COORDINATES ALL THEIR CARE.

GROUPS MAY INCLUDE EXPRESSIVE THERAPIES INCLUDING DANCE/MOVEMENT, ART, HEALTH AND WELLNESS, TRAUMA RECOVERY, SUBSTANCE USE TREATMENT AND MENTAL HEALTH SYMPTOM MANAGEMENT.
